The Fair Cup competition is an individual exhibitor competition and is subject to the ACF General Rules.

Competition Format: Each exhibitor will complete, design, and execute a floral arrangement utilizing surprise packaged materials provided by Angelina County Fair.

Design Guidelines: Each individual should review the design guidelines prior to the Fair Cup competition. Exhibitors will also have an opportunity to ask questions at the mandatory pre-event meeting.

- Exhibitors will have **one hour** to execute their design, which includes placing finished arrangements on the judging table.
- The exhibitor is responsible for positioning their design in the required location designated for judging.
- **No extra embellishments on the judging table. Arrangements only.**
- Exhibitors are not allowed to design on the judging table. Once the arrangement has touched the table, the exhibitor is not permitted to touch the arrangement from that point on. If design is touched after placing it on the judging table, the exhibitor will result in disqualification.
- All materials will be provided by the Fair.

- Exhibitors **MUST** utilize items provided. Each exhibitor will be furnished with materials, including fresh flowers, foliage, container, and decorative elements. The flowers, foliage, and supplies will be the same for each exhibitor.
- Each exhibitor will receive the same type of decorative elements, but the design of each element can be different amongst exhibitors. The exhibitor is responsible for determining which materials they will use in the design of their entry.
- No outside adornments are allowed.
- All elements of the entry should reflect or enhance the theme which will be revealed prior to the fair. Each exhibitor's design will be a sole effort with no assistance from anyone in any manner.

Exhibitors must provide their own floral tools. Permissible tools include:

JUDGING: The show will select qualified judges for each competitive event. Any questions about the judging criteria may be directed to a committee member. Judging will be based on the following seven categories (the score rubric is located on page 4):

- Design Elements – Line, Form, Color, Texture, Size, and Space
- Design Principles – Balance, Proportion, Scale, Rhythm, Contrast, Harmony, and Unity
- Mechanics – Neatness and Cleanliness of overall Design, Proper Coverage of Foam, and Sturdiness of Design
- Execution – Adequate use of provide materials and overall expression of the principles and elements of design.
- Creativity – Uniqueness of Design and Techniques

Only judges and Committee members will be allowed inside the competition area while judging is in progress.

No cell phones, watches, earbuds/headphones or any type of communication devices are permitted during the competition. Any exhibitor found communicating with anyone outside of the competition could result in immediate disqualification. Talking or gestures from outside the barrier will not be tolerated and result in immediate disqualification. The judges' decisions will be considered final.

Winning entries will be announced after the competition/judging is complete. Approximate times will be given at the contest. **Grand and Reserved are REQUIRED to display arrangements in the VIP Section of ACF Expo (Same location as art exhibits).** *Floral Design entries will not be eligible for the ACF Auction.*
