Angelina County Farm Bureau (AFB) in an effort to promote Angelina County producers and the development of agriculture within our county has chosen to reward Angelina County Fair (ACF) that exhibit County Bred and Owned animals.

The Definition of COUNTY BRED and OWNED Animals:

- (1) Must be conceived by a dam and sire that are owned and located in Angelina County prior to breeding.
- (2) Dam must remain in Angelina County during gestation.
- (3) Breeder must attest that this criterion was met.

Exhibitor must be a member of an Angelina County Farm Bureau family and in good standing, (Father, Mother, or Guardian) at time of validation. Grandparent, siblings, or other relative's membership may not be used. Must submit a completed application and picture of animal to be exhibited. Incomplete forms or without pictures will not be considered for awards. Applications must be turned in to ACFB at validation.

Exhibitors must meet the rules and guidelines of the Angelina County Fair.

Categories eligible for these awards are steers, beef heifers, commercial heifers, swine, goats, lambs, market rabbits, fillies, and geldings.

The highest placing County Bred animal in each category will be awarded a monetary award for first (1st, second (2nd), and third (3rd) places.

The awards will be given out during the award ceremony prior to the sale. Any awards not picked up within 30 days will be voided.
